### From the Working Group

This will be an abridged newsletter as we have to get the information about the development of the Monash/Caulfield Campus out to affected residents and we have been given very short notice by DSE of the Information Sessions. More about that later.

Two members of your Working Group attended a meeting of representatives from 70 Residents' Groups from across country and city areas of Victoria. Anger at the Planning Policies of the Bracks Government was evident. Residents decided to hold a protest rally on the steps of Parliament House on May 3/06. A subsequent meeting of the Working Group decided to call this loose coalition of groups "Planning Backlash."

I counted 13 members of MEG at the rally and that was marvellous considering that Melbourne was gridlocked on May 3 because of accidents on the Monash and in the Burnley tunnel. (The people bringing our sound system into town also had an accident!)

Tony Resci of Sydney SOS was the guest Speaker. Tony warned us of the dangers for existing residents when planning decisions are not made at local level as is happening in NSW. He referred to the 'ram, jam and cram brigade'...and we all know about them. There is a push in Victoria to take planning decisions out of the hands of local government. That means that residents will not have a say about what happens in their area. We must make sure that doesn't happen.

# PRIORITY DEVELOPMENT PANEL (PDP) INQUIRY MONASH/CAULFIELD CAMPUS

I received this notice on May 10. Registration for the Information sessions was requested by May 12...I have asked for an extension and have been informed that replies will be accepted on Monday May 15 and certainly no later than Tuesday May 16.

A key aim of the project (Monash Fusion) is to integrate the University Campus with the activity centre "to create an active, vital and sustainable centre" and proposes:

- New education off ice and student accommodation buildings
- Redeveloping Caulfield Plaza and associated car parking
- New active retail, public open space and upgrading of Campus Green
- Upgrades to connections between Caulfield Station, the University Campus, Dandenong Road and Derby St.

Concept plans have been prepared by Equiset.

As a next step and prior to providing its report to the Minister, the PDP is seeking Community and key stakeholder input in respect of the proposed planning scheme provisions.

As key stakeholders we are invited to Information Sessions on Friday May 19. We are also invited to provide the panel with a written submission regarding the project. These have to sent to the PDP by **Thursday June 1 /06.**
