From the Convenor's Desk

My first attempt to write this column comprised the tale of our first MEG Meeting in 2 years, the anxiety about wondering if anyone would come...or not?" I deleted all of that to tell you this tale of your **rapidly expiring democracy.**

At Council Meeting June 28 on a vote of 6-2 (one absentee) an East Ward park 'bit the dust'...or the concrete! MEG lobbied all Councillors. As usual, only 2 replied. When campaigning to be elected, Greens candidate Polly Morgan wrote the following to Residents Against the Stadium, (Reported on FB June 28.)

"I think the project should be reviewed and that we need to find an alternative for the stadium. I don't think it should be at Percy Treyvaud Park."

So, with a viable alternative at Holmesglen and another at CSC, for Council to consider Ms. Morgan voted for Percy Treyvaud Memorial Park to be the site for a stadium. The other Greens councillor from South Ward joined her. Does that strike you as being slightly skewed?

In 2020, all councillors declared "A Climate Emergency.' In 2021 six of them voted to destroy 67 mature trees, **16 of which are deemed by Council to be significant**, and some 100 shrubs and replace them with a concrete stadium (bunker style) and 130 saplings. Our research shows that saplings take 20-40 years to do what mature trees already do for the environment..i.e absorb pollution, counter the heat island effect, provide shade, provide oxygen. An East Ward councillor in moving the motion told a lengthy story about how she had been harassed because she supported the destruction of a park. The Chair allowed this to go on and on and on! One has to marvel at the lack of relevance.

Please note that the actions of this Council mirrors the actions of developers First own the site, moonscape it and then fill it with STUFF!

At the MEG Meeting...Heritage & Fast Tracking

We were pleased to welcome Clifford Hayes MLC for Southern Metropolitan Region as Guest Speaker at our meeting. Clifford has been involved in planning issues as a councillor,

mayor and now as a parliamentarian. He has put forward a number of Bills to the Upper House. Read this one.

"a bill to Parliament to give local residents across more say in planning decisions by moving amendments to the Planning and Environment Act that would have given Councils the capacity to set mandatory height controls on new buildings and also modify the capacity of VCAT to overturn Council planning decisions."

This Bill was defeated in the Upper House by 22 votes to 18.

He had also proposed that **developer contributions to political parties be banned.** Both Liberal and Labor MLCs voted against this. His most recent Bill to establish an Inquiry into Heritage issues has been approved and this is what the Bill proposes...

- 1. At a national level create a Federal Minister for Heritage and a Federal Department.
- 2. At Victorian level, separate Heritage from Planning with a separate Minister and a separate Department.
- 3 ..Remove Heritage decisions and appeals from VCAT and place them under a Victorian Heritage Tribunal.
- 4 .. At local level require Councils to have a Heritage Department.
- 5 ..Require developers to pay for heritage advice on any building they propose to demolish but not permit them to appoint the Heritage expert. Council to appoint the expert with local knowledge from an accredited panel. Heritage adviser will be required to demonstrate that no conflict of interest exists in each case Investigate whether 2 levels of heritage protection at local level is sufficient.

MEG will let you know when submissions can be made.

Supreme Court Action taken against Glen Eira Council...The Age June 19

John Wylie was not notified of an application for a 5 storey development in Glenhuntly Rd. Elsternwick behind his home. "Under delegation" approval was given by Glen Eira's Planning Dept. for a 5 storey development in a section of Glenhuntly Rd. which has a 2 storey height limit. The Department refused an application by the developer for 7 storeys so he has gone to VCAT and John Wylie has gone to the Supreme Court against the entire Council even though Councillors did not make the decision.

"The project is directly north of the Wylies' 4000 sq.m. home."
Fast tracked? We're not sure about that. No notification to certain affected residents?
We're sure about that.

H.S. May 19.... Cladding emergency avoidable

An apartment block in St. Kilda was branded "uninhabitable" in May due to highly inflammable cladding and the residents were ordered to leave on May 21. Port Phillip Council reached an agreement with the Owners' Corporation for emergency remediation and the residents were allowed to stay while the building was made safe. Would you be staying under these circumatances?

Tree blitz in west to boost greenery...The Age May 14

"The state government will fund planting 500,000 trees in Melbourne's west starting in September." This is because western suburbs have "far less green cover than other parts of Melbourne." (GOSH! Who would have thought it!) The Government renowned for destroying thousands of trees has recognised that "Locals in newer suburbs have noted much hotter conditions compared to older suburbs with established trees."

Try telling that to Stonnington councillors. Destroying trees seems to be in the DNA of the majority of them!

Officeworks plants 787,104 trees....an advertisement

"Restoring Australia initiative is one of Officeworks' commitments to making a positive difference to the environment. Officeworks plants trees and establishes native plants to help restore natural landscapes and habitats."

We think Stonnington Council should invite Officeworks to tell councillors what it should be doing to protect the "natural landscape and habitat" at Percy Treyvaud Memorial Park!

The Age....Spectrum...May 1...Even Virginia Woolf was felled by the majesty of trees "In the State Library of Victoria the ruthless tree-felling of the colonialists is documented in paintings and photographs. It was as though the new arrivals found the sight of trees....unbearable.......By the late 19th century, the tree stump had become a national symbol for white culture and sovereignity."

Some Stonnington Councillors clearly belong in the 19th century while disseminating the myth that this is a modern forward thinking minor form of government!

Top private schools grow richer.....The Age June 18

"it's gobsmacking that these private schools claim they need public funding."

Gobsmacking indeed! There are so many private schools in Victoria and they are all partially funded by the taxpayer. They do not **share** facilities that are partially paid for by the taxpayer. If they were to do that ratepayers of municipalities such as Stonnington would not be spending millions of dollars building more and more sporting facilities and in the process destroying parks. Rare butterfly effect: \$530m plan detailed....The Age June 24

The sighting of "the endangered Eltham copper butterfly in bushland near Montmorency station" put a stop to State Government's "\$530millon track duplication on the Hurstbridge line." A section of the line was ditched because it would have cut through the butterfly's

habitat. This would have contravened Federal environmental law. A resident said that "if the government had carried out the proper environmental assessments earlier......"

Stonnington News

In the Winter Edition of this paper that promotes Stonnington Council we read of the report to come to Council re the 'independent review of 13 sites for the 'indoor courts.'

"The outcome of this review is to continue discussions with Vicinity Centres operators of Chadstone Shopping Centre, to investigate the concept of a multipurpose sport and recreation facility to support the need for additional indoor sporting court. Discussions will also continue with Holmesglen Institute to better understand their interest. A report will be brought back to Council IN JULY....."

As we all know by now <u>this wasn't true!</u> It was dealt with on June 28 with one councillor absent. Holmesglen rated high in the review but was ignored by 6 councillors in their feverish haste to moonscape a park in East Ward. If the Greens councillors had stood by

their so-called 'GREENS' credentials and pre-election promises, there may have been a chance of saving the Park AND saving millions of dollars by giving serious consideration to the Holmesglen option. The only issue against considering this was that there would be a wait for Holmesglen to complete its Master Plan. **Your rates at work!**

Talking about your rates

At Council Meeting on June 28 a majority of councillors voted to impose the 3.5% rates increase. This comprises the 2% rates relief we were given last year and the 1.5% increase which State Government allows. Some councillors made much of the percentage of resident renters in Stonnington. Apparently 48% of Stonnington's population rents accommodation. Of course SOMEBODY pays rates on rented properties so Council will still get its 3.5% increase from SOMEONE and, inevitably, it will be the renter because costs must be passed on by landlords eventually. It was mentioned that as property values have risen so much this year people who own their own houses can easily afford a rate increase of 3.5%. The logic of that entirely escapes us but who are we to question!

Chadstone turns shops into offices The Australian...June 23/2021

"Melbourne's Chadstone shopping centre has unveiled plans for its fourth office tower, with the 9 storey to comprise over 20,000sq.m. of office space. The tower will be known as the **1 Middle Road** development, and Chadstone centre manager Michael Whitehead contends it will "set a new standard" for suburban properties.

This is about the 40th extension of Chadstone since it opened in 1960 AND apparently they want to have a 4 court stadium there as well.

1755, 1757-1759, 1761-1763 & 1765 Malvern Rd. Glen Iris

All of these 'art deco' homes are to be demolished for Korowa to build a day-care centre and primary school with, needless to say, swathes of artificial turf....undoubtedly a "cooking the kids" project. We have used those words of Dr. Greg Moore on many occasions with reference to artificial turf. MEG simply can't understand why anyone with a brain doesn't recognise the danger of 'global warming' that artificial turf presents. Council has declared a "Climate Emergency" and council's addiction to artificial turf can be seen at Penpraze Park where there are now only a few trees on the Tooronga Rd. side and that stuff is a direct contradiction of Council's own policy. Gardiner Park is another glaring (exactly) example of this....and there are other many instances of council using the stuff. Leaves us breathless!

<u>Please note the following</u>. From June 2021. Amendment VC180 designates the Minister for Planning as the Responsible Authority for new non-government schools and upgrades where there is an estimated cost of \$3million or more.

Mutual Respect Charter...The Age May 27

Stonnington Council has a Mutual Respect Charter which indicates that everyone has to be nice to everyone else on Council. It means among other things, MEG assumes, that councillors are not permitted to speak or shout directly to other councillors rather than

going through the Chair as we saw at Council Meeting on June 28. It's supposed to be "a safe, respectful workplace."

The Age reports that this is "Good news after such a long periodof fraught relations between councillors leading to a broken, toxic and dysfunctional council before last year's elections." The report goes on to deal with the BUT "it looks like history is repeating itself." The gossip is that relations between a small number of councillors "are so bad that a formal mediation process is underway." (Your rates at work!)

Thankfully the CEO assures us that "mediation is common in modern workplaces." What a relief!
